WHAT NOT TO BRING
LATEX PAINTS & STAINS **
Fluorescent Light Bulbs
Electronics

Ammunition
Medications

** If you have Latex Paints or Stains, you
can mix it with kitty litter or saw dust and
let sit. Once dried, you may throw it out
with your normal trash.

COVID-19 SAFETY PROTOCOLS

- **All HHW must be placed in the trunk or rear of the vehicle.** Waste will not be accepted through any passenger door. Trunk must be accessible before entering site. The only items in your trunk should be HHW items for disposal.
- You **may not leave your vehicle.**
- Items should be packed in cardboard boxes. Plastic tubs, gas cans of any material or any other **containers will not be returned.**
- **Please wear a mask.** Event staff will be wearing masks and social distancing.

New 2020 COVID-19 Protocols for Household Hazardous Waste Collections

In order to keep everyone safe during the COVID-19 pandemic Household Hazardous Waste Event Coordinators are implementing mandatory rules for HHW Collections. Event Coordinators **reserve the right to deny anyone not complying with these rules.**

Preparation Before the Household Hazardous Waste Collection Event



When at Home

- Bring your face mask with you. Event Staff will be wearing masks and observing social distance protocols.
- All Household Hazardous Waste (HHW) must be placed in the trunk of the vehicle or in the rear of the vehicle for SUV's, hatchbacks or crossovers.
- Waste through any passenger door will not be accepted.
- Your trunk must be accessible and unlocked before entering site.
- The only items in your trunk should be those HHW items you want disposed.
- If possible, items should be in their original containers and sealed to prevent spills.
- Most items should be packed into cardboard boxes. Plastic tubs will not be returned. Gas cans, plastic or metal will also not be returned.
- If you have any waste that you are not sure if we will take or not contact us before 3pm the Friday before the event at (603) 444-6303 extension 2019 or via email at dcarruthers@nccouncil.org
- Please do not bring passengers or pets to household hazardous waste collections, drivers only.
- If bringing in waste for other people contact us before 3pm the Friday before the event at (603) 444-6303 extension 2019 or via email at dcarruthers@nccouncil.org. Bring a piece of mail with the waste originator's name and address.
- Driver's license for proof of residency will be needed. If your driver's license is not current, please supply current information (piece of mail with name and address) for your waste.
- Please watch for emails or check www.nccouncil.org for updates or a cancellation of this event.
- All events are dependent on health and safety factors and may be cancelled at any time. If you have registered we will notify you of any changes to the event scheduling or participation rules via emails.



At the Collection

- Do not get out of your vehicle for any reason.
- Please wear a mask and close all windows before you reach the staff working the event.
- Please pay attention to staff through visual signals.
- Have driver's license or piece of mail with name and current address ready for verification.
- HHW vendor will be unloading your vehicle. If you have waste that is not accepted, staff will let you know where it can be disposed of.
